Points for reference:

1. Junior Memberships are open to application in fields of Badminton, Billiard, Bowling, Swimming, Table Tennis and Tennis.
2. Junior Member must be aged between 12 - 28. Their performance in sports will be under review every year for the continuity of membership. Junior Membership shall cease upon the Junior Member reaching the age of 30.
3. Entrance fee: \$900*
4. Monthly subscription: \$100*
(*or such other sum as the General Committee shall from time to time determine)
5. All charges are non-refundable.
6. Application form must be completed in detail.
7. Junior Membership is temporary and has no voting rights.
8. Junior Members are not entitled to bring guests to use the Club facilities other than the catering services provided by the Club.
9. Expenditure of the Junior Member in the Club should not exceed \$3,000 per month.
10. A Junior Membership shall be applied for with a guarantee by his/ her parent/ guardian to settle all his/ her expenses in the Club. Payment must be settled by autopay. (For applicants of the age 18 years or above, no guarantee for payment is required.);
11. No parking label shall be issued to a Junior Member.
